  - A repeal of Policy FA, Facilities Development Goals/Priority Objectives as it no longer effectively serves its purpose as a standalone statement of purpose
  - An update to Policy KB, Parent and Family Engagement. The board should work with the DAC to review the recommendations and revise the policy as appropriate to reflect the local district's needs and circumstances.
