**Mission: Possible ...
to make Colorado a national leader**

The Colorado Association of School Boards and Great Education Colorado have developed **Mission: Possible**, an interactive online budget tool that allows Coloradans to make spending and revenue choices for the state budget.

The two education organizations teamed up on this project because they believe all state residents must understand Colorado's fiscal challenges and all possible solutions. Because of amendments to the state constitution, it is voters, not legislators, who make the most important decisions about Colorado's finances.

We named the budget simulation **Mission: Possible** because we believe Coloradans will want to design budgets that will allow our state to fully fund our schools and invest in other essential public services. Once they have completed a balanced budget, they can share it with friends and family, neighbors, co-workers and elected leaders – even the governor.

Finally, a seat at the table

If you come from a large family, you are familiar with sitting at the “kids table” for holiday dinners. You know, that rickety old card table that gets hauled out a couple of times a year, when there are no more seats at the dinner table? That's how it used to be for Colorado school districts on important decisions concerning urban renewal. Now, thanks to House Bill 15-1348, districts have a seat at the big table when it comes to making important decisions.

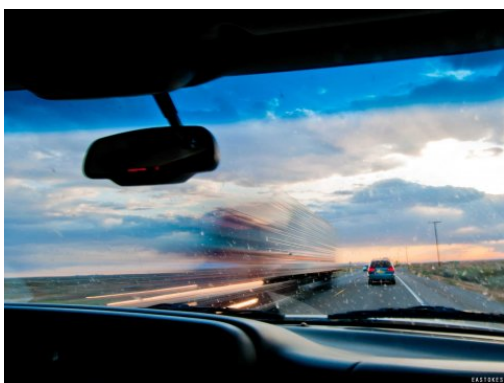
Gov. John Hickenlooper signed the bill in to law in May 2015, but it didn't kick in until January. CASB worked for many years with legislators and community groups to pass the bill.

The law states that a municipal urban renewal authority must include one elected member of the local school district, along with special-district and county representatives. In the event an urban renewal authority encompasses more than one school district, those school boards must work together to identify their representative.

Urban renewal projects rely on the growth of school, county, special district and municipal property taxes over a 25-year period to alleviate blight and fund urban-level development. Under HB15-1348, school district representatives on an urban renewal board can now flag how these projects will impact the number of students they serve, traffic patterns around schools and concerns that otherwise might be missed by the municipality. The bill further stipulates that the urban renewal authority must negotiate with impacted school districts on how best to share revenues and address costs associated with development. If agreement cannot be reached, a mediation process begins.

The nuances of the bill can be tricky, so CASB advises you to consult your district legal team if there are urban renewal authorities in your community. Read the [full text of the bill](#) and a [sample revenue sharing agreement](#).
